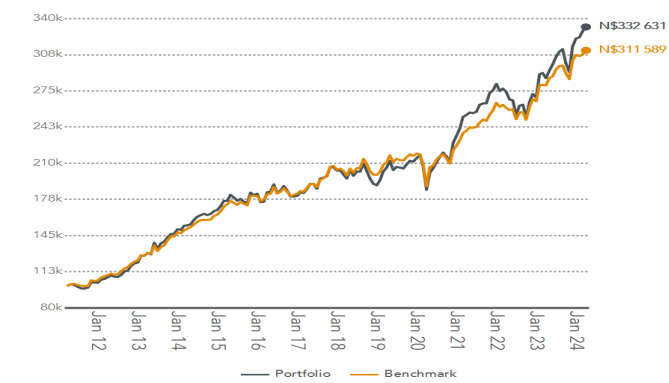

### Advice Costs
